AHF (Architectural Heritage Fund, Transforming Heritage) funds had been received to carry out a survey and to create plans. Llŷn AONB funds had been received to carry out the renovation work. This work was expected to be carried out in the summer 2023 by the Original Roofing Company from Blaenau Ffestiniog.</p> <p>A great deal of work has been done by the trustees to obtain a new S16 agreement with Natural Resources Wales. The new S16 agreement would be held by the Bardsey Island Trust and a new conservation plan would be written at the same time.</p> <p>It was announced that Enlli has received a Dark Sky Sanctuary designation from the NDA (International Dark Sky Association). There had been significant media attention around the world following the announcement, as well as links with local schools. An official launch event was held in Aberdaron in the company of Derek Walker, Welsh Commissioner for Future Generations, Aled Hughes, BBC Radio Cymru and Dani Robertson from Project Nos. Thanks were expressed to everyone who had been involved in the application and the work following the announcement.</p> <p>2023 was a busy year in the island's houses again as in previous years. Some highlights from the guest questionnaire were provided. 90% of those who had</p>
